


The meeting was called for allotment of subjects to all the faculty members for the even semester of the Academic year 2023-24.

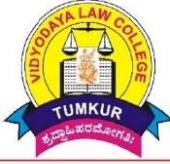
The Academic Committee was informed to prepare the time-table as per subjects allotted to the faculty members.
