





**THE FACTS OF THE CASE:**

Sri Raju and his wife Seethamma of the Hindu Family residing in Tumakuru Taluk, Tumakuru District, Karnataka state. The said Raju acquired 10 acres of Agricultural land in Tumakuru village from his Ancestors, in survey no.5/1 which is irrigated and he developed the said land as a Garden land in 5 acres of land and remaining 5 acres of land developed has Mango garden. During this Raju and Seethamma gave birth to a Two daughters and two sons. Thereafter, the said Raju died leaving behind his wife and four children, all the children's are minors, seethamma take care of minor children's and acting as guardian, to look after the minor children and family affairs income from the family itself. She and Two male children performed the two daughter's marriage in the year 1980; thereafter they were settled with their husbands at Tumakuru.

Subsequently, out of 10 acres of land 1 acre of land was sold to One Chinnaya for the benefit of family, and remaining 9 acres of land was partitioned among the two male children and mother, the married two daughters were also asked their shares in the partition.

The male children and widow mother refused to partition and allot their shares. Then, the two daughters named Rajini and Roja filed the partition suit in the Tumakuru claiming the equal shares. Subsequently, the Government of India enacted amendment to the Hindu Section Act, and Male children refused to allot the shares of Female daughters. Hence, the present suit has been filed before the Hon'ble court.

MOOT COURT PROBLEM -2

Criminal case - (3 years LL.B., -Section -B)

THE STATEMENTS OF FACTS:-

1. On 06.01.2021, at Plot No. 55 SB Estate, Gandhi nagar, Tumakuru, one Mr. Mahesh (deceased) was levelling the land, with the help of a JCB bearing No KA-06-5567. That, the said land is owned by the brother of accused namely Mr. Preetham and the brother of accused had entered into a land development agreement with the complainant i.e., Mr Ajay kumar, Mr Ajay kumar is the builder and it is since last 2 years, he was carrying out the work at Gandhi Nagar, Tumakuru.
2. The accused namely Mr. Hemanth on 06.01.2021, at around 12 noon came to the said land threatened the complainant by pointing gun at him. Thereafter, Mr. Hemanth pointed the Revolver at JCB driver Mr. Mahesh and fired a bullet at him his Revolver which hit the driver on his head. The deceased got a fire arm injury on his forehead. The case of the Prosecution is that the accused murdered the JCB driver. It is on that pretext offence came to be registered Under Section 302, 506(b), of IPC and under Section 7, and 27(3) of the Arms Act 1959, against the accused on the basis of report lodged by the Complainant.(Ajay).
3. The police machinery reached the spot and consequently the panchnama was prepared, the statements of Eye witness were recorded and the items seized were sent for chemical analysis. The Injured was immediately sent to the hospital and after some time it was informed that the deceased has succumbed to the injury. The accused was present at the spot with the Revolver and was arrested at the spot where the incident took place. The post-mortem report disclosed the cause of death as being caused due to Fire arm injury.
4. The basis for the case of the prosecution is that the accused person had the intention to kill the deceased, it is a specific case of the prosecution that the accused had the requisite Mens Rea which led to the murder of the deceased. It is the defence of the accused that there was some prior litigation, which was pending in respect of the site where the incident took place and also the intention to kill the JCB machine towards him and he feared for his life, When he was moving back he lost his balance and which triggered the firing.
5. The investigation came to be completed and charge-sheet came to be filed in the court of 1<sup>st</sup> Addl.chief Judicial Magistrate, Tumakuru. The court of 1<sup>st</sup> Addl.chief Judicial Magistrate, Tumakuru committed the case to Sesion Court for Trail as the offence Punishable under Section 302 is exclusively triable by the Court of Sesion.

MOOT COURT PROBLEM -3 on Constitution case

Sneha, a citizen of Nepal came to India on official duty in the month of December 2022. Before returning to Nepal, She wanted to visit Mysuru Palace with intent in mind. Then, She arrived at Mysuru, Karnataka on 24<sup>th</sup> December 2022 and stayed in a Hotel at 10, Sunder Street, Maharaja Police Station.

She arrived at Chamundi Railway Station on 1<sup>st</sup> Jan 2023 at about 14.00 hours to avail K.R.S Express at 23.00 Hours for paying a visit to Mysuru palace. She had, however, a wait listed ticket and she approached a Train ticket Examiner at the Station for confirmation of berth against her ticket. The train ticket examiner asked her to wait in the ladies Waiting Room. She accordingly came to the ladies waiting room and rested in.

At about 17.00 hours on 1<sup>st</sup> Jan, 2023, two unknown persons (later identified as one) Ashoka, a tout who posed himself as a very influential person of the Railway and one Randir a railway ticket broker having good acquaintance with some of the Railway Staff of Chamundi railway station approached her, took her ticket and returned the same after confirming reservation in Coach NO. S-3 (Berth NO.17) of K.R.S Express. At about 20.00 hours Ranadir came again to her with a boy named Salman and told her to accompany the boy to a restaurant if she wanted to have food for the night. Accordingly at about 21.00 hours she went to a nearby eating house with salman and had her meal there. Soon after she had taken her meal, She came back to the Ladies Waiting room.

At about 21.00 hours Ashoka along with Rafi khan a parcel supervisor at Chamundi Railway station came to the ladies Waiting Room before boarding the train. She appeared to have some doubt initially but on being certified by the lady attendants engaged on duty at the ladies Waiting room about their credentials she accompanied them to Yatri Niwas. Satya, a Khalasi of electric Department of Chamundi Railway Station joined them on way to Yatri Niwas.

She was taken to room No. 102 on the first floor of Yatri Niwas. The room was booked in the name of Ashokaa against Railway card pass No. 3638 since 30<sup>th</sup> December 2022. In room No.102 two other persons namely, one James, a parcel clerk of Chamundi Railway Station and Rocky, parcel cleaning Agent were waiting. Sneha suspected something amiss when Ashoka forced her into the room. Awanish bolted the room from outside and stood on guard outside the Sunil Sharma (Age 16 years boy helper in Railway on contract basis) took liquor inside the room and also forcibly compelled her to consume liquor. All the five persons who were present inside the room brutally committed gangrape on Sneha, who was in a state of shock and daze.

When she could recover, She managed to escape from the room of Yatri Niwas and came back to the Platform where she again she met Ranadir and found him talking to Ashoka. Seeing her plight, Ranadir presented to be her savior and also abused and slapped Ashoka. Since, it was well past midnight and Chamundi express had already departed, Ranadir requested Sneha to accompany him to his residence to rest for the night with his wife and children. He assured her to help entrain Chennama Express on the following morning.

Thereafter Ranadir accompanied by Sreemukha, a friend of Randir took her to the rented flat of Sreemukha at 55, Chrale street, Police station, Mysuru. There Ranadir raped Sneha and when she protested and resisted violently Ranadir and Sreemukha gagged her mouth and nostrils intending to kill her as a result Sneha bled profusely. On being informed by the land lord of the building following the hue and Cry raised by Sneha. She was rescued by Chrale street, Police station, Mysuru.

On the basis of mentioned facts, one social activist and Advocate Mrs. Chandra Bose and few NGO Members filed petition Under Article 226 as Public interest Litigation against Railway Board and Union of India infavour of Sneha, the victim, and many such other victims of rapes committed in the Railway premises, saying that the main accused in the instant case are employees of the Railways, and the Union of India and they are perpetrators of the heinous crime of Gangrape repeatedly committed upon the helpless victim Sneha.

It was on the basis of the above facts that the High court awarded a sum of Rs. 10 lakhs, as compensation to Sneha, as High court was of the opinion that the rape was committed at the building (Rail yatri Niwas) belonging to the Railways and the gang rape was perpetrated by the Railway employees.

Now the case is before the Supreme court. The points are to be argued before the Supreme Court are :-

- 1). Whether Sneha Who is a Foreigner and not an Indian Citizen is entitled to any relief/ compensation under Constitution of India?
- 2) Whether the commission of an offence like rape by the person concerned, would make the railway or the Union of India liable to pay compensation to the victim of the offence on the ground of vicarious liability?
- 3) Whether the accused Sunil Sharma (age 16 years boy) can be treated as an adult for the offence of Gang Rape?

**MOOT COURT PROBLEM - 1.**

**Civil Case - 3-YEARS LL.B. - Section-A 6<sup>th</sup> Semester**

**Facts of the case:**

A minor girl by name Shree Lakshmi daughter of Kantharaju through her mother-Shantha Kumari filed suit against her father - Kantharaju, her grandfather - Channaiah, her grandmother - Jayalakshamma, her uncle - Krishna, her aunt - Jayapadma and Guruswamy-purchaser, stating that herself and the defendants No. 1 to 5 are the coparceners of Hindu Undivided Joint Family having properties bearing Sy. No. 151/2 of Gulur village is the ancestral property. Sy. No. 20/2 of Kaidala village is acquired in the name of Jayalakshamma (i.e. the grandmother of Shree Lakshmi) out of the joint earnings in the year 1996, the same was sold to Guruswamy though the Registered Sale-deed dated 18-08-2011, only with an illegal intention to deprive her right. Shree Lakshmi demanded for allotment of her share with Kantharaju, as he refused to allot her share Shree Lakshmi filed suit for partition and separate possession of her legitimate share in the said properties. Kantharaju admitted the relationship and stated that Shree Lakshmi is not entitled for any share in the schedule properties as she is not residing with him. Later Shree Lakshmi filed impleading application under Order 1 Rule 10 (2) of C.P.C. to impleade her grandfather-Channaiah's brother Late. Gujjarappa's sons Basanna, Dibbanna, Hanumanthappa and Chandraiah as defendnats. After the said application was allowed, they were brought on record as defendants No. 7 to 10. Shree Lakshmi filed an application under Order 6 Rule 17 of C.P.C. for inclusion of properties bearing Sy. No. 42/3, Sy. No. 15/2 and house bearing Khatha No. 220 of Gulur village in the schedule to the plaint.

After service of notice Basanna, Dibbanna, Hanumanthappa and Chandraiah appeared, Basanna and Chandraiah filed written statement jointly contending that there is no relationship with Shree Lakshmi, there is no existance of joint family, as the lands bearing Sy. No. 42/3, Sy. No. 15/2, belonged to their father Late. Gujjarappa, who acquired them by the income arising from rearing Sheeps and Goats and house bearing Khatha No. 220 of Gulur village was the only ancestral property. Futher contended that Basanna had filed a suit in O.S.315/1990 seeking partition against Dibbanna and his brothers which came to be ended in a Compromise as per the decree dated 09-09-1992, hence there is no joint family status between any of the parties to the suit and sought for dismissal of suit as the plaintiff is not entitled for any share in the said properties.

**MOOT COURT PROBLEM - 2**

**Criminal Case – 3-YEARS LL.B. 6<sup>th</sup> Semester - Section-A**

**Facts of the case:**

One Kamamma - the second wife of Manjappanaika, who was the father of Gowri @ Gowamma through his first wife. Kamamma was having two daughters, i.e., Sugandha and Sujatha, she used to reside alone at Hosamane at Horabylu village, by the side of the house of Gowri. The husband of Gowri was also no more and she was staying along with her two children.

Subramanya and Gowri having illicit relation for which deceased Kamamma used to object and scold and was an obstacle in their way. On 23.08.2010, Subramanya and Gowri conspired with each other to eliminate Kamamma and get rid of the obstacle for their relation and at about 9.00 PM they entered the house of Kamamma and near the cattle shed, assaulted on her head and neck by club and committed her murder.

Thereafter they stole the gold chain, pair of ear studs, one gold ring and mobile belonging to Kamamma. Thereafter, with the assistance of Seetharam, they tied the dead body with a saree to a long pole and carried it to the land of one Dinamani by the side of a water channel and on a mound with the help of a crowbar dug a pit and buried the dead body of Kamamma with an intention to destroy the evidence of murder in order to screen themselves from legal punishment. Subramanya took the umbrella and threw it on the shelter of the bus stop at Kuppali village and sold the gold ornaments to a jewellery shop at Rippanpet and sold the mobile to one Ashok @ Meeranath at Suratkal.

On 24.8.2010, son of <sup>Gowri</sup> Subramanya by name Alok informed Yogeesh that his mother-in-law Kamalamma is not found since 23.8.2010. Thereafter he started searching but he could not find and as such he went to Koppa Police Station and filed a missing complaint.

On 9.12.2010 at about 9.30 PM, Seetharam met Yogeesh and told that about 4 months back, Subramanya and Gowri by giving brandy, took him by saying that he had some work and told that they have committed the murder of Kamalamma and kept the body in the cattle shed and asked him to carry the dead body to bury the same. When he did not agree to the said work, they threatened that they will also kill him and being afraid of the same, he went with them, there Subramanya got removed the gold ornaments over the dead body and they all carried the dead body and buried the same.

On 19.12.2010, Sugandha went to the Police Station and filed the complaint. Thereafter Sanjeev Naik deployed his staff to apprehend the accused and during the course of investigation, after apprehending the accused persons, on the basis of their voluntary statements, gold ornaments and other incriminating materials were recovered and the accused persons showed the places where they had buried the dead body of Kamalamma and in the presence of the Sub Divisional Magistrate, the body of deceased Kamalamma was exhumed on 11.12.2010 and after examining the body and the clothes found over it, the body was identified as that of deceased Kamalamma. After completion of the investigation charge sheet came to be filed against Subramanya, Gowri and Seetharam, for the offences punishable under Sections 120-B, 379, 302, 201 read with Section 34 of I.P.C.
