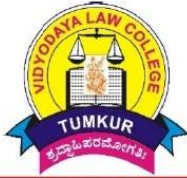

Objectives:-




Role of Mentors:-
