



"FD 457 Exp-10/2016 Finance Department (Exp-10), dated 20.03.2017.

Administrative Department has sought the concurrence of Finance Department for admission of teachers who are appointed on or after 11.07.2009 in 19 Law Colleges to Grant-in-Aid. Finance Department opinion is as follows:-

 As per the UGC regulation incorporated in G.O. No. ED 37 UNE 2009 dated 24.12.2009 the following are the requisite qualification for fresh appointments of teachers to be made on or after 11.07.2009.

"As from 11.07,2009 the teaching staffs who have not acquired the qualification prescribed by the UGC are not entitled for availing the benefit of UGC revised scheme unless they acquire NET/SLET/Ph.D. through course work and that no M.Phil shall be recognized thereafter until then they shall continue to be in the pre-revised UGC scale or in the State pay scale, as the case may be.

In respect of fresh recruitment made after 11.07.2009—through Public Service Commission validly constituted Selection Committees, Boards of Appointment for Universities, teachers who do not possess NET/SLET/Ph.D. through course work shall be on probation for a period of two years and shall acquire NET/SLET/Ph.D. through course work for declaration of the period of probation and that they will continue to draw salary in the existing scale of pay only, viz., Rs.8,000-13,500. Failure to acquire NET/SLET/Ph.D. through course work will debar them from continuing in the service after the period of probation".

Thus a pass in NET remains as essential requirement for appointment as Assistant Professor on or after 11.07.2009 and as from 11.07.2009 the qualification of M.Phil will no longer be the criteria as it used to be earlier.

Admission to Grant-in-Aid is only from prospective effect for which the teachers should necessarily possess the required qualification/compulsory requirements prescribed by the UGC. Therefore, in respect of the teachers who have acquired the requirement of pass in SLET/NET but after two years of their appointment may be admitted to Grant-in-Aid from prospective effect and they may be assigned UGC pay scale by relaxing the requirement of passing in NET/SLET within two years from the date of appointment after 11.07.2009.

In cases of appointment after 11.07.2009 M.Phil cannot be the criteria as it used to be earlier. Hence, the teachers who have acquired M.Phil prior to 11.07.2009 cannot be now admitted to Grant-in-Aid by relaxing the requirement of a pass in NET/SLET.

As regards certain teachers who possess the qualification of LLM but have not acquired NET/SLET/Ph.D. and are continued in service beyond two year from the date of their appointment, they cannot be admitted to Grant-in-Aid by extending the time to acquire the required qualification nor they can be assigned State pay scales by giving two years time to clear NET/SLET as there is no provision for the same.

As regards the case of Teachers of Education Department who have been admitted to Grant-in-Aid by giving 2 years time to pass NET/SLET, which has been quoted as precedent, Law Department may be informed that such a decision has been taken without Finance Department's approval. Hence, action is being taken to get the sanction reviewed. Since a wrong precedent cannot be a binding precedent, the benefit wrongly given to teachers of Education Department cannot be given to the teachers of Law Colleges.



Admission to Grant-in-Aid is only from prospective effect for which the teachers should necessarily possess the required qualification/compulsory requirements prescribed by the UGC. Therefore, in respect of the teachers who have acquired the requirement of pass in SLET/NET but after two years of their appointment may be admitted to Grant-in-Aid from prospective effect and they may be assigned UGC pay scale by relaxing the requirement of passing in NET/SLET within two years from the date of appointment after 11.07.2009.

In cases of appointment after 11.07.2009 M.Phil cannot be the criteria as it used to be earlier. Hence, the teachers who have acquired M.Phil prior to 11.07.2009 cannot be now admitted to Grant-in-Aid by relaxing the requirement of a pass in NET/SLET.

As regards certain teachers who possess the qualification of LLM but have not acquired NET/SLET/Ph.D. and are continued in service beyond two year from the date of their appointment, they cannot be admitted to Grant-in-Aid by extending the time to acquire the required qualification nor they can be assigned State pay scales by giving two years time to clear NET/SLET as there is no provision for the same.

As regards the case of Teachers of Education Department who have been admitted to Grant-in-Aid by giving 2 years time to pass NET/SLET, which has been quoted as precedent, Law Department may be informed that such a decision has been taken without Finance Department's approval. Hence, action is being taken to get the sanction reviewed. Since a wrong precedent cannot be a binding precedent, the benefit wrongly given to teachers of Education Department cannot be given to the teachers of Law Colleges.


