Key facts:

→ Section 377 of IPC criminalized consensual sexual intercourse between persons of the same-sex for being "against the order of nature".

→ In 2009, before the Delhi High court, the Naz Foundation (India) Trust ('Naz') challenged the constitutionality of Section 377 for violating Article - 14, 15, 19 and 21 of I.c. Judgment - held that it violates these Articles.

→ In 2013, this decision was reversed in Koushal case and held that only the Parliament could decriminalize homosexuality.

→ Five individuals from the LGBTQ+ communities (Navtej Singh Johar, Ritu Datta, Arushi Kapur, Anon Math and Sunil Mehra) filed a new writ petition challenging the constitutionality of Section 377.

Issues and Decisions: [Q of Law]

(i) A-14 as it discriminates against individuals on the basis of their "sexual orientation" and "gender identity"?

(ii) The right to autonomy and dignity u/A-21 by penalizing private consensual acts between same-sex persons?

(iii) The right to expression u/A-19(a) by criminalizing the gender expression of the LGBTQ+ community?

The Litmus Test for removal of Section 377:
[Something that is used to make a judgment about whether someone or something is acceptable]

The S.C. tested the constitutionality of sec-377 against the principles of equality, liberty, dignity under Article 14, 19 and 21.

(i) Right to Equality and Non-Discrimination:
The court deemed that sec-377 arbitrarily punishes individuals who engage in same-sex relationship. To substantiate this, the court noted that sec-377 criminalizes and punishes individuals who engage in consensual intercourse against the order of nature to protect women and children.
[Sec-377] [Posco Act].
Therefore, the court held that the unequal treatment of LGBT individuals violates A-14.
Further, the court held that sec-377 is manifestly arbitrary as it does not distinguish b/w consensual and non-consensual sexual acts between adults.

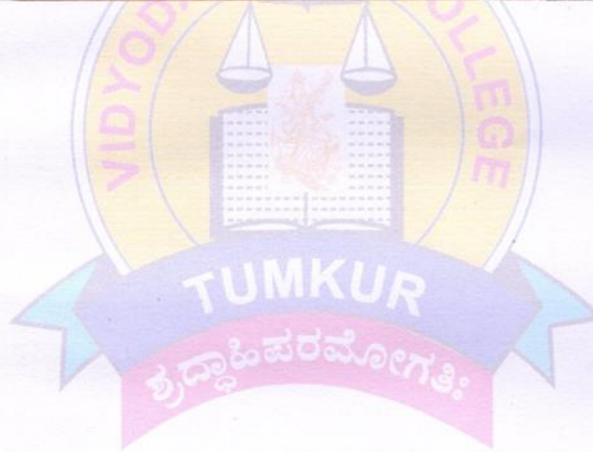

Ratio Decidendi:-
In order to ensure the protection of the human rights of LGBT people regardless of whether those rights are opposed by a majority Govt, discrimination of the same-sex, it must take positive action in order to achieve equal protection and to grant the community "Equal citizenship in all its forms".

Obiter Dicta:-
Sexual orientation is the part of the right to Expression and an integral part of the right to privacy.

Personal Perspective:-
History owes members of the LGBT community and their families an apology for the delay in redressing the shame and marginalization they have suffered over the centuries.

I.P.C:-
Section-377 - Unnatural offences-
Whoever voluntarily has carnal intercourse against the order of nature with any man, woman or animal, shall be punished with imprisonment for life, or with imprisonment of either description for a term which may extend to ten years, and shall also be liable to fine.


It targeted people exercising certain choices and treated them as "less than human" and encourages prejudice and stereotypes accompanied by debilitating social effects. This violates A-14, which is very basis of non-discrimination.

(i) Freedom of Expression:-
The court acknowledged that all persons, including LGBTQI individuals, had the right to express their choices without any fear.
[S-377 - Private consensual acts do not disturb public order].

(iii) Right to Life and personal Liberty:-
The court held that S-377 violates human dignity, personal autonomy and the fundamental right to privacy. Every individual has the liberty to choose their sexual orientation, seek companionship and exercise it within their private space. Therefore, the court held that the scope of the right to privacy must be widened to incorporate and protect 'sexual privacy'.

Conclusion:-
The court upheld the right of equality among citizens and equal citizenship of all members of the LGBTQI community in India. Thus, it read down Sec-377 to exclude consensual sexual relationship between adults, whether between same-sex individuals or otherwise. Sec-377 will continue to apply to non-consensual sexual activity against adults, sexual acts against
