Access to justice is the ability of people to seek and obtain a remedy through formal or informal institutions of justice for grievances. There is no access to justice where citizens (especially marginalized groups) fear the system, see it as unfamiliar and do not access it where the justice system is financially inaccessible, where individuals have no lawyers, where they do not have information of knowledge of rights or where there is a weak justice system. Access to justice involves legal protection, legal awareness, legal aid and counsel, adjudication and enforcement. Nyayah Abhay Hast programme helps in this regard.

To strengthen this Best Practice, Vidyodaya Law College has signed MOU with District Legal Service Authority. And also adopted Yellerampura Village and signed MOU with Yellerampura Gram Panchayath.

This Clinic solves the legal issues with the required officers, free of cost.

- **Village Survey/ Door-to-door Survey**

Here students are allowed to visit each and every house in a village to communicate with the house hold personally, identify problems faced by them main on legal problems suffered by them, submit it to the Legal -Aid

- **Lok Adalats**





Memorandum of Understanding

I. Context.

Whereas Vidyodaya Law College, Tumakuru was established in 1958 and being an oldest Law College in our State, the college was affiliated to Karnataka State Law University Hubballi and Recognized by Bar Council of India, New Delhi.

Whereas District Legal Services Authority, Tumakuru was established Under the Legal Services Authorities Act 1987 with an intent to provide legal services within the District.

II. Scope of the Agreement

This Memorandum of Understanding is signed between Vidyodaya Law College, Tumakuru as FIRST PARTY and District Legal Service Authority, Tumakuru as a Second Party.

1. To achieve the free 'Legal Aid' under Article 39-A of Indian Constitution in promotion of free and fair justice.
2. To do all necessary action plans for ensuring commitment to the fundamental duties of the citizens under Part IV-A of Constitution.
3. Principles for making legal services available under the provisions of the Enactment.
4. In ensuring legal literacy to local society.
5. In securing the social justice to the needy.
6. Securing social security to the marginalized community in the society.
7. In providing free and competent legal services to weaker section.
8. Encouraging the settlement of disputes by way of Lok Adalat.
9. Undertake and promote joint research in the field of legal services with special reference to the need for such services.
10. Conducting the legal awareness Programs.
11. To exchange and provide staff and infrastructure support as may be feasible according to the new SOP issued by Karnataka State Legal Services Authority.

The Validity of the MOU is initially for the period of % years from date of signing this MOU. The Validity can be extended on mutual agreements after that.


